## **Automatic Weather Alerts a No-No!**

Recently there have been a number of postings regarding the use of (EAS) automatic severe weather alerts initiated by the National Weather Service on amateur radio repeaters.

Undoubtedly, this is a good service to be able to provide, however repeater owners need to know that this may be in violation of Part 97 regulations however well intentioned this might be.

This issue was brought up in at a meeting in the Western PA Section. After some very comments were brought out pro and con on this issue, this was referred to the ARRL's headquarters in Newington, CT in February 1997. John Hennesey at the ARRL referred this issue to the FCC, and the FCC replied back to John that EAS activating amateur repeaters (stations)for weather alerts without amateur intervention is in violation of Part 97.

The FCC's comment was that amateur radio is not an emergency communications service although amateur radio is used to support emergency communications. If, upon receiving a weather alert tone, an amateur repeater or station immediately sends out a warning message over amateur frequencies, that action has violated one, possibly two, regulation(s) of Part 97.

The first violation is that a transmission was made and was not identified. The second violation is that the transmission may have been caused by a non-amateur at the weather service who transmitted the weather warning tone.

Possible ways to do weather alerting without violating Part 97 would be:

**1.** To receive the weather alert and the repeater automatically change the courtesy tone and tail message so that with the next amateur transmission the repeater tone and tail message signify a weather alert is in effect. Or, 2. Upon receipt of a weather warning by a control-operator, the control op manually trips the repeater into a weather alert.

When we signed our 610 forms for our amateur license, we agreed to adhere to Part 97. Regardless how we feel on this issue, we still need to follow Part 97. If we feel strongly that unattended EAS activation of weather warnings on amateur repeaters should be permitted, we need to file a petition with the FCC for a change of the rules.

# LMCC PETITION HAS LOCAL ANGLE

When the Land Mobile Communications Council proposed that portions of the 440 band be taken away from the Amateur Radio Service, the ARRL requested that amateurs who belong or have contact with LMCC member organizations contact them and express their opposition to the proposal. One of the most recognized

members of LMCC is the American Automobile Association.

Another member was APCO, the Associated Public Safety Communications Officers. HARC President and CQ VHF columnist Bob, WA3PZO contacted the Chairman of APCO's Volunteer Resources Committee. Bob had interviewed the Chairman, Tom, W3EAG, last year. Tom forwarded APCO's comments to Bob. They indicated that they were opposed to using the amateur radio 440 band. The news made national headlines in many amateur radio publications and news services.

HARC also filed comments in opposition to the LMCC proposal. As of press time, the FCC has not ruled on the proposal.
