Amateur Radio Emergency Communications Highlights October 15 HARC Meeting



Walt and Dick will speak on the role amateur radio has in assisting with communications in Pennsylvania. Amateur radio operators were activated in several nearby counties during the recent Pope visit to Philadelphia.


In many areas of the state amateurs participate in emergency drills and provide essential communications. Luzerne County ARES recently received a thank you for their assistance during the planning and implementation of the 2015 Wilkes-Barre Triathlon. Chief Howard Kocher of the Lehman Township Police said, "The dedicated work of the volunteer radio spotters certainly and very notably made the event run smoothly and safely. As the Police Departments in the Back Mountain area are outside the 10 mile radius of the power plant, we rarely have the opportunity to work with the Amateur Radio community. This event offered a valuable training exercise and demonstrated the value of the Public Safety/Amateur Radio interface."

Pope Francis visit to the United States September 22 – 27

Throughout the 5 day event 6 special event amateur radio stations were on the air to commemorate the event. Call signs from the Washington, DC area were K3P and N4P. From New York and New Jersey K2P. W3FRC/WMF was on the air from southeastern Pennsylvania and W3P and **WM3PEN** were on the air in Philadelphia. Over 26000 contacts were made during event. WA3PZO coordinated local, national, and international publicity for the event. HARC members participating included WA3GM, W3HWK, AB3EO, N3ZZK, WK2G, and WA3PZO.




WM3PEN QSL and the certificate offered.

Military Auxiliary Radio System (MARS), Communications Exercise 7-10 NOV 2015 From Chon Gann, K3DHS

I am sure most of you are aware of the Department of Defense (DoD) auxiliary program called the <u>Military Auxiliary Radio System</u> (<u>MARS</u>). The MARS program is a joint service program supported by the service branches of the U.S. Army and the U.S. Air Force. Today's MARS program has grown considerably into a modern contingency radio communications system for the DoD ensuring our nation can communicate during times of complex catastrophes and in cyber denied or impaired environments. MARS is the program that trains, organizes, and tasks dedicated citizen volunteer amateur radio operators authorized to operate in support of the DoD Global High Frequency Enterprise Radio Network (GHFERN). The MARS program conducts frequent regional and national exercises to ensure the readiness of MARS operators.

As part of U.S. Army MARS Region 3 (MD/DC, VA, WV, PA, DE) we would like to request your support, assistance and joint participation during the next national level exercise scheduled for 7-10 NOV 2015. This exercise is based on a Coronal Mass Ejection (CME) similar to the 1859 Carrington event. During this exercise both U.S. Army and U.S. Air Force MARS stations will attempt to contact local and regional amateur radio stations and nets using their amateur call signs to obtain requested DoD information to be used in various status reporting on local conditions. Requested data may include weather reports and or status of various infrastructure areas like, power, telecommunications, medical and emergency services. All responses to the exercise requests by MARS stations should be real-world status information. Please do not make up notional or false reports to any request for information. For example requests for local weather data should be the current conditions. Requests related to power should be the current electrical grid status for the area reporting (i.e. lights on or lights off). The most active time period for MARS stations to interact with local and regional amateur stations will be between 8-9 NOV 2015. MARS stations, using there amateur call sign, not their military call sign, will make voice or common mode contact on regional and local VHF/UHF and HF amateur radio nets and other local ad hoc amateur activity.

Stamps For the Wounded



HARC members are collecting postage stamps for the Stamps For the Wounded program. *Stamps for the Wounded* accepts any U.S. or foreign stamps that are not torn or damaged. They have

also requested each stamp should have at least a quarter-inch margin around the stamp. Do not try

to either to peel or steam the stamp off the original envelope.

So save the stamps from your qsl cards or other mail. They do not need the common Flag Forever stamp. Bring the stamps to a club meeting and give them to Rich, AB3EO, who will mail them.

Many stations, including DX, included extra stamps with their qsl cards for WM3PEN that we are able to pass onto the SFTW program. We had 4 stamp albums donated and several mailings once stations received an insert with SFTW information in their qsl card. We even had inquiries from 2 clubs interested in starting their own program.

"Clarity on Parity" — the Video!

From the ARRL Letter 10/8/2015 In August, the ARRL acted to address objections and concerns being raised by representatives of community and neighborhood associations regarding the Amateur Radio Parity Act of **2015** — H.R. 1301 and S. 1685. "Clarity on Amateur Radio Parity" made it clear that the bill would *not* create new federal policy with respect to outdoor amateur antennas, nor would it require homeowners associations to approve huge radio towers. Now, a **new video** — "The Amateur Radio Parity Act of 2015 — Separating Fact from Fiction" — doubles down on the arguments contained in the League's August statement. ARRL President Kay Craigie, N3KN, said the video will be made available on Capitol Hill to make sure that Members of Congress have correct information, instead of misrepresentations. "This short video is a companion piece for the "Clarity on Parity" statement on the ARRL website," President Craigie said. "The video not only explains what H.R. 1301 and S. 1685 are all about but knocks down specific misinformation that opponents have been circulating on Capitol Hill."

The nearly 6 minute video begins by explaining Amateur Radio — and especially its public service role — in layperson's terms. It includes video clips of FEMA Administrator Craig Fugate, KK4INZ, who addressed the value of Amateur Radio in emergencies when he spoke at the ARRL Centennial National Convention in 2014, and of Sen Roger Wicker of Mississippi, the sponsor of S. 1685, the Senate bill.

As the presentation outlines, radio amateurs living in deed-restricted neighborhoods may face "cookie cutter prohibitions" on outdoor antennas. It notes, however, that the FCC recognizes a strong federal interest in effective Amateur Radio communication from residences and, in 1985, adopted the PRB-1 limited preemption of state and local regulation of Amateur Radio antennas. As the statement — and now the video — point out, the Amateur Radio Parity Act of 2015 would extend that limited preemption to private land-use restrictions.

The legislation "takes the time-tested 30 year old reasonable accommodation standard [in PRB-1] and applies it to deed-restricted communities," the video states. "Unfortunately, there is a smear campaign against this legislation, and we need to respond to these blatant lies."

The video stresses that neighborhood homeowners associations (HOAs) would have the flexibility to reasonably accommodate amateur antennas in a manner that best suits the particular community, although HOAs could not just say "no." The legislation also does not take away any jurisdiction from community associations, nor does it negate any private contracts, the video asserts. "HOAs, not the hams, will decide on height and placement of radio antennas," it says. "Amateur Radio operators in these communities just want a seat at the table to negotiate a reasonable accommodation from HOAs, but HOAs don't want there to even be a table." As the video concludes, "Opposing reasonable accommodation is just unreasonable."

President Craigie suggested that League members could use the video at club meetings to help their fellow hams understand the legislation and show why it's so important to urge members of the US House and Senate to support the bills, which have more than 100 supporters in both chambers. "If your club has an e-mail reflector, Twitter feed, Facebook page, or newsletter, you could add a link to the video to make it easy for people to find it online," she said.

President Craigie said her Congressman in Southwest Virginia is a co-sponsor of H.R. 1301. "I went to his official website and sent an e-mail thanking him and politely refreshing his memory about the appreciation we hams in the district have for his support," she said. "I'd like everyone whose representative is already a cosponsor to call a local office or put a short e-mail on the official website saying, 'Thank you!' This is a great way to keep the legislation in the Representative's mind and to let him or her know that the decision to co-sponsor is still very much on *our* minds. We should never take their support for granted. Speak out for Amateur Radio!"

Pennsylvania "67" Challenge Award

Amateur Radio operators around the world have the opportunity to participate in the Pennsylvania "67" Challenge. The Challenge, sponsored by the Holmesburg Amateur Radio Club, is to make contact with all 67 Pennsylvania Counties. The Challenge is open to all amateur radio operators regardless of individual station capabilities. All contacts must be 2-way communications made in real time. These contacts may be on any Amateur Radio band/mode.

Contacts made using repeating devices such as FM repeaters, Amateur satellites, moonbounce, and keyboard-to-keyboard contacts through digipeaters/nodes are valid, because these QSOs are made in real or near-real time. Contacts using IRLP, Echolink, or D-Star are valid as long as a radio is being used by both operators. All contacts must be made from the same county.

As an incentive Pennsylvania "67" Challenge certificates may be earned by working stations in 20, 40, 60, or all 67 Counties. Paper or electronic QSLs are acceptable. The contacts can be verified by a local club officer or mailed to the Holmesburg Amateur Radio Club. Complete rules are posted on the HARC website.
